TSMC Building Basement Parking Lot Rules

Approved at the College of Technology Management 1st College Administrative Meeting for the 2008 academic year on August 7, 2008

Amended and approved at the College of Technology Management 9th College Administrative Meeting for the 2008 academic year on May 6, 2009

- Article 1 In order to effectively manage the TSMC Building basement parking lot (hereinafter referred to as the “Parking Lot”), and in accordance with the National Tsing Hua University On-Campus Vehicle Management Regulations and with the Revised Key Points for National Tsing Hua University Vehicle Entrance Fees and Violations Handling, these Rules are established.
- Article 2 The Parking Lot is only for parking by teachers who have successfully applied for a University parking permit.
- Article 3 The campus card can be used 24 hours a day to enter the Parking Lot through the gateway. The rolling shutter gate is open during the daytime and closed at night, and is automatically opened and closed by vehicle sensors. The gate is left open during the day, Monday to Friday, during working hours (07:30-19:00 in summer, 07:30-18:30 in winter); other times, the gate opens automatically when a vehicle enters by card or exits from the basement near the gate sensor area.
- Article 4 Vehicle height in the Parking Lot is limited to 200 cm.
- Article 5 There are 77 parking spaces in the Parking Lot. With the exception of some handicapped spaces and reserved spaces, the other spaces may be parked in on a first-come, first-served basis. When there are special events, the College will adopt the principle of flexible handling.
- Reserved parking spaces: The Dean, Vice Dean, and the head of each College department (institute), totaling 10 spaces; handicapped parking spaces: 2 spaces reserved outside the basement elevator entrance; for a total of 12 spaces, with 66 spaces remaining.
- Article 6 The Parking Lot only provides parking spaces, and does not take responsibility for vehicles or personal belongings; in the event of a natural disaster or other force majeure damage, the Parking Lot will not be liable for any compensation.
- Article 7 It is strictly prohibited to place any explosive or flammable objects in a vehicle; any parking person who destroys the Parking Lot's facilities or structure shall be liable for damage compensation.
- Article 8 Vehicles entering and leaving the Parking Lot shall follow the indicators and speed limits. Vehicles must park only in the parking area parking spaces, not in driveways, nor obstructing any passage. Vehicles in violation of the rules will be reported to campus security guard for handling; those causing any damage to facilities shall be liable for compensation or repair.

Article 9 These Rules shall come into force after they have been approved by the College's College Administrative Meeting, and the same shall apply to any amendments. Any matters not covered in these Rules shall be handled in accordance with resolutions of the College's College Administrative Meeting.
