CTM Student SDGs in Practice Program Award Regulations

Approved at the 3rd College Affairs Meeting for the 2021 academic year on December 1, 2021

- Article 1 The National Tsing Hua University College of Technology Management (hereinafter referred to as the “College”) establishes these Regulations to encourage its students to implement the United Nations Sustainable Development Goals (“SDGs”), to enhance innovative activities and sustainable development awareness within the College, to integrate local care and exert social influence, and to provide awards for students' innovative and practical SDG activities.
- Article 2 The qualified applicants as per these Regulations are three or more students from each department, institute, and in-service program of the University who form a team (one of which must be a student enrolled in the College), with priority given to inter-departmental teams.
- Article 3 Applications for this Award shall be announced by the College’s Office of Sustainable Development in each academic year. The Office of Sustainable Development will invite College faculty members and alumni to serve as the selection committee. Applications shall be based on the United Nations 17 SDGs, linked to one or more of the SDG indicators, and incorporate the local characteristics of the Taoyuan, Hsinchu, and Miaoli region. The Award emphasizes practical work in the field and encourages the team to develop and propose ideas across departments and disciplines. The evaluation criteria are as follows.
- (1) Linkage to SDGs indicators 30%
 - (2) Linkage to local characteristics 30%
 - (3) Innovation 20%
 - (4) Proposal feasibility 20%
- Article 4 Applications shall require submitting an application form, including a brief biography of the applicant team members, the purpose of the project, the execution method, the expected results, the description and budget of the program to be awarded, and other information favorable to the application.
- Article 5 The amount of this Award is limited to NT\$30,000 per project (depending on the current year's funding, subject to announcements), intended for student teams to concretely implement the SDGs in Practice program.
- Article 6 Student teams receiving this Award shall actually implement their projects; keep records during the project period; submit a report on the results to the College’s Office of Sustainable Development within one month of the project’s end date; and make an oral report as a team.
- The College’s Office of Sustainable Development will invite College faculty members and alumni to serve as the evaluation committee, evaluating the specific results and potential of the projects, and select a number of Outstanding SDGs Program Awards and present them with certificates and awards (up to NT\$50,000 exactly).

- Article 7 If an awarded student team has excellent concrete results in implementing an SDGs in Practice project, the College will invite alumni to assist in counseling and provide specialized or financial support to expand the social impact of the SDGs in Practice project.
- Article 8 The funding source for this Award shall be donations from College alumni and the College's own funds. If funding is insufficient, the College may make necessary adjustments depending on the financial situation.
- Article 9 These Regulations shall come into effect after they have been approved by the College Affairs Meeting.
